A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, CORRECTING A SCRIVENER'S ERROR IN RESOLUTION NO. 18-156 VACATING ALL OF THE PLATTED 5-FOOT UTILITY **WITHIN** PARCEL "A", **EASEMENT** "RESERVE EDGEWOOD".
