A RESOLUTION OF THE CITY COMMISSION OF THE CITY FORT LAUDERDALE, FLORIDA, WAIVING THE COMPETITIVE SOLICITATION **SELECTION** AND PROCESSES AND, SUBJECT TO AND CONDITIONED ON FINAL PASSAGE OF ORDINANCE C-19-11, THE MANDATORY COMMISSION APPROVAL CONTAINED IN THE CITY OF FORT LAUDERDALE PROCUREMENT ORDINANCE. AND **APPOINTING** THE CITY COMMISSION AS THE DIRECT PURCHASING AUTHORITY FOR THE CITY OF FORT LAUDERDALE, IN CONNECTION WITH DEVELOPMENT OF A JOINT GOVERNMENT CENTER CAMPUS WITH BROWARD COUNTY, FLORIDA, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City and Broward County, a political subdivision of the State of Florida, ("Broward County"), entered into an Interlocal Agreement between Broward County and City of Fort Lauderdale for a Joint Government Center Campus ("Interlocal Agreement"); and

WHEREAS, pursuant to Section 4 of Ordinance No. C-17-26, codified at Subsection 2-176(e)(19) of the Code of Ordinances of the City of Fort Lauderdale, Florida, the competitive solicitation and selection processes contained in the City of Fort Lauderdale Procurement Ordinance do not apply to "[p]urchases of goods or services for which the provisions of this Ordinance are waived by the City Commission by resolution."; and

WHEREAS, Pursuant to Section 4 of Ordinance No. C-19-11, if passed at second reading on June 4, 2019, Subsection 2-176(e)(17) of the Code of Ordinances of the City of Fort Lauderdale, Florida, will provide that the mandatory commission approval amount and the competitive solicitation and selection processes will not apply to "[p]urchases of goods or services for which the provisions of this Ordinance are waived by the City Commission by resolution."; and

WHEREAS, Section 2.2 of the Interlocal Agreement provides that the "City will appoint the City Commission as the direct purchasing authority for the City,"

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the competitive solicitation and selection processes contained in the City of Fort Lauderdale Procurement Ordinance are waived in connection with the development of a Joint Government Center Campus with Broward County.

<u>SECTION 2</u>. That, subject to and conditioned on final passage of Ordinance No. C-19-11, the mandatory commission approval amount contained in the City of Fort Lauderdale Procurement Ordinance is waived in connection with the development of a Joint Government Center Campus with Broward County.

<u>SECTION 3</u>. That the City Commission of the City of Fort Lauderdale, Florida, is appointed as the direct purchasing authority for the City of Fort Lauderdale in connection with the development of a Joint Government Center Campus with Broward County.
