TITLE: Resolution Waiving the Competitive Solicitation and Selection Processes

and Mandatory Commission Approval Amount Contained in the Procurement Ordinance Relating to the Creation of a Unified Direct Procurement Authority between the City and Broward County

(Commission Districts 1, 2, 3 and 4)

Recommendation

It is recommended that the City Commission adopt a resolution waiving the competitive solicitation and selection processes and, subject to and conditioned on final passage of Ordinance C-19-11, the mandatory commission approval amount, contained in the City of Fort Lauderdale Procurement Ordinance in connection with the development of a Joint Government Center Campus with Broward County.

Background

On May 7, 2019, the City Commission approved the Interlocal Agreement between Broward County and City of Fort Lauderdale for a Joint Government Center Campus (CAM 19-0465).

This Interlocal Agreement calls for the creation of a Unified Direct Procurement Authority between the City and Broward County for the purposes of procuring consultant and project services related to the Joint Government Center Campus. The Interlocal Agreement also provides for the City's appointment of the City Commission as the direct purchasing authority for the City within thirty days of the Interlocal Agreement's effective date.

Pursuant to Subsection 2-176(e)(19) of the Code of Ordinances of the City of Fort Lauderdale, Florida, the competitive solicitation and selection processes contained in the City of Fort Lauderdale Procurement Ordinance do not apply to "[p]urchases of goods or services for which the provisions of this Ordinance are waived by the City Commission by resolution."
