TITLE: Motion to Approve Contract for Purchase of Roll-Off Dumpster Services –
MST Scrap Metal Inc d/b/a MST Dumpsters - \$384,420 (estimated three-
year total) – **(Commission Districts 1, 2, 3, and 4)**

Recommendation

It is recommended that the City Commission approve a three-year contract, in substantially the form attached, for the purchase of roll-off dumpster services from MST Scrap Metal Inc d/b/a MST Dumpsters (“MST”) in the three-year estimated total of \$384,420, and authorize the City Manager to approve two additional one-year renewal options contingent upon appropriation of funds.

Background

This contract will be for collection and disposal services of bulk trash, construction and demolition debris, garbage, recyclable materials and yard trash with disposal fees being passed through to the City at cost as specified in Invitation to Bid No. 12274-893 (“ITB”) issued on April 17, 2019. The contract amount for hauling is \$61,140 per year with annual estimated disposal fees of \$ 67,000.

The Procurement Services Division solicited the ITB and received nine bids and one no-bid. After performing due diligence, staff determined that MST has met all of the specifications of the bid and has been deemed the lowest cost, responsive and responsible bidder.

The detailed schedule of services lists primary collection sites including Mills Pond, Holiday Park, Snyder Park and the Fiveash Water Treatment Plant. Roll-off service is also utilized by the City for projects and special events. Materials are collected and transported to a licensed disposal facility.

Resource Impact

There will be a current fiscal year impact in the amount of \$32,035. Funds for this purchase are available on the FY 2019 Operating Budget in the accounts listed below. Funding for future years is contingent upon approval and appropriation of the annual budgets.
