Outdoor Event Agreement with Supreme Team LLC for Sandz Fort Lauderdale Caribbean Music Festival - (Commission District 2)

## **Recommendation**

It is recommended that the City Commission approve an application for a temporary beach license and outdoor event agreement and authorize the City Manager to execute the agreement on behalf of the City of Fort Lauderdale with Supreme Team LLC for Sandz Fort Lauderdale Caribbean Music Festival.

## **Background**

City staff has been working closely with the event organizer regarding event topics, such as logistics, maintenance, and security as detailed below. Amplified music was discussed, and the event organizer was advised of the noise ordinance and possible concerns.

The event organizer will pay for all event costs and submit the required certificates of insurance. The agreement provides that the organizer will pay \$500 for each event use of the beach. The event organizer will secure all other necessary permits and licenses that are required from other agencies. Civic and merchant associations have been notified as appropriate regarding this event. Event details are included in the event application as attached.

Authorization for the execution of the event agreement is contingent upon the City Attorney's Office receiving and approving a validly executed agreement.

The Supreme Team LLC hosts several events during the year in a variety of locations in Fort Lauderdale. At their June 9, 2019 event on Fort Lauderdale Beach, the group did not comply with the site plan submitted. They blocked beach access to the water and drove a vehicle, that is not approved during turtle-nesting season, onto the sand. Staff met with the event promoters to ensure all regulations are adhered to.
