TITLE: Motion to Approve Contract for the Fort Lauderdale Executive Airport
Decorative Street Posts Project – Sagaris Corp. - \$360,010 -
(Commission District 1)

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for Fort Lauderdale Executive Airport Decorative Street Posts Project with Sagaris Corp. in the amount of \$360,010.

Background

This project is for the purchase and installation of forty-one (41) decorative, colored, pre-cast concrete street posts within the airport's property. These street posts will replace existing aluminum posts that are damaged and do not meet current standards. The street posts will include street names as well as the airport's name and logo.

On April 18, 2019, the Procurement Services Division issued Invitation to Bid No. 12236-693. Two bids were received on May 14, 2019, and both were reviewed for compliance with the solicitation specifications. The bid submitted by Sagaris Corp. has been deemed the lowest cost, responsive, and responsible bidder recommended for award. Both vendors that responded are either a Minority Owned Business Enterprise, Women Owned Business Enterprise, or Small Business Enterprise.

Resource Impact

There will be a fiscal impact to the City in the amount of \$360,010 for the contract award, allowances and \$20,000 for estimated in-house management fees for a total of \$380,010. Funds for this contract in the total amount of \$227,658 are available in the FY 2019 Community Investment Plan in the accounts listed below with \$152,352 contingent upon the approval and appropriation on July 9, 2019, of the consolidated budget amendment CAM #19-0028.
