TITLE: Motion to Approve Contract for the SW 2nd Avenue Median Parking

Project — Continental Construction USA, LLC - \$263,384.10 -

(Commission District 4)

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the SW 2nd Avenue Median Parking Project with Continental Construction USA, LLC, in the amount of \$263,384.10.

Background

The City was contacted by local business owners from District 4 (SW 2nd Ave and SW 30th St) for assistance in resolving the shortage of parking spaces and thereby meet their customers' and employees' parking needs.

After working with consultants and business owners, Parking Services staff presented a design that will convert two existing sodded medians with no curbing into 36 angled parking spaces. The project will also include speed humps, cross walks, and landscaping improvements and a pave drain system to handle storm water drainage.

On April 9, 2019, the Procurement Services Division issued Invitation to Bid No. 12278-693. Eight bids were received on May 8, 2019, and the bids were reviewed for compliance with the solicitation specifications. The apparent low bidder, American Design Engineering Construction Inc., was deemed non-responsive due to failure to meet the requirements of the bid, including but not limited to, experience, and failure to provide necessary and critical information. The bid submitted by Continental Construction USA, LLC was reviewed for compliance with the specifications of the bid, and has been deemed the lowest cost, responsive, and responsible bidder recommended for award. All of the vendors that responded are either a Minority Owned Business Enterprise, Women Owned Business Enterprise, or a Small Business Enterprise.

Resource Impact

There is a current fiscal impact to the City in the amount of \$263,384.10. These funds are available in the FY 2019 Operating Budget in the account listed below.
