AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE CLASSIFICATION TABLE OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY CREATING AND ADDING ONE CLASS, AND AMENDING THE TITLE, CLASSIFICATION LEVEL, MANAGEMENT CATEGORY, AND PAY GRADE OF ONE CLASS, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.
