

ORDINANCE NO. C-19-15

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE CLASSIFICATION TABLE OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY CREATING AND ADDING ONE CLASS, AND AMENDING THE TITLE, CLASSIFICATION LEVEL, MANAGEMENT CATEGORY, AND PAY GRADE OF ONE CLASS, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, the City Manager and the Director of Human Resources recommend amending the Classification Table of the Pay Plan of the City of Fort Lauderdale, Florida,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That Exhibit 4, Classification Table, Non-Bargaining Unit, of Ordinance C-18-37, the Pay Plan of the City of Fort Lauderdale, Florida, is hereby amended by creating and adding in alphabetical order by title, one class, to wit:

SECTION 2. That the Community Program Coordinator class contained in Exhibit 4, Classification Table, Non-Bargaining Unit, of Ordinance C-18-37, the Pay Plan of the City of Fort Lauderdale, Florida, is hereby amended as follows:

SECTION 4. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed to the extent of such conflict.

SECTION 5. That this Ordinance shall be in full force and effect beginning the first full pay period following its final passage.
