Conservation Commission to Accept a Subgrant for the Development of a  
Habitat Conservation Plan for Special Events at the Beach – \$75,000 -  
**(Commission Districts 1, 2, and 4)**

**Recommendation**

It is recommended that the City Commission approve an agreement between the Florida Fish and Wildlife Conservation Commission and the City of Fort Lauderdale to accept a subgrant for the development of a Habitat Conservation Plan (HCP) for special events at the beach, in substantially the form attached, and authorize execution of the agreement and any other documents required to accept the funds.

**Background**

The U.S. Fish and Wildlife Service provided financial assistance to the State Florida Fish and Wildlife Conservation Commission for the development of a Habitat Conservation Plan for special events within the City of Fort Lauderdale. As a collaborator on the project, the City has been approved for a subgrant of \$75,000 from the Florida Fish and Wildlife Conservation Commission with a required 11.6% match. Matching funds have been identified in the general fund grant match account. Funds will be used to create a Habitat Conservation Plan (HCP) for special events in the City of Fort Lauderdale that will benefit multiple listed species in Florida.

**Resource Impact** This action will result in a positive impact to the City in the amount of \$75,000 with a City Match of \$25,000, which will be appropriated to the accounts below contingent upon the approval of the Consolidated Budget Amendment CAM 19-0028.
