

RESOLUTION NO. 19-136

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING EXECUTION AND DELIVERY BY THE CITY MANAGER OF AN EASEMENT DEED IN FAVOR OF FLORIDA POWER & LIGHT ("FPL") COMPANY FOR INSTALLATION AND OPERATING OF AN ELECTRICAL TRANSFORMER IN AN EASEMENT AREA MEASURING SIXTEEN FEET BY SIXTEEN FEET A SKETCH AND DESCRIPTION OF WHICH IS ATTACHED TO THE EASEMENT DEED ATTACHED HERETO AS EXHIBIT "A" AND MADE A PART HEREOF SAID EASEMENT AREA GENERALLY BEING LOCATED IN THE PERIPHERY OF THE LEASEHOLD AREA FOR PARKER PLAYHOUSE.

WHEREAS, the City of Fort Lauderdale owns the lands occupied and leased to Parker Playhouse; and

WHEREAS, improvements to the Parker Playhouse will require the installation and operation of a Florida Power & Light electrical transformer and appurtenant electric power equipment generally located on the periphery of the Parker Playhouse leasehold property; and

WHEREAS, the granting of such an electrical utility easement to Florida Power & Light ("FPL") Company for the installation and operation of the transformer and appurtenant electrical equipment serves a valid municipal purpose, and is in the best interests of the public;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:



The undersigned, in consideration of the payment of \$1.00 and other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, grant and give to Florida Power & Light Company, its affiliates, licensees, agents, successors, and assigns ("FPL"), a non-exclusive easement forever for the construction, operation and maintenance of overhead and underground electric utility facilities (including wires, poles, guys, cables, conduits and appurtenant equipment) to be installed from time to time; with the right to reconstruct, improve, add to, enlarge, change the voltage as well as the size of, and remove such facilities or any of them within an easement described as follows:

Reserved for Circuit Court

See Exhibit "A" ("Easement Area")

Together with the right to permit any other person, firm, or corporation to attach wires to any facilities hereunder and lay cable and conduit within the Easement Area and to operate the same for communications purposes; the right of ingress and egress to the Easement Area at all times; the right to clear the land and keep it cleared of all trees, undergrowth and other obstructions within the Easement Area; the right to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees or limbs outside of the Easement Area, which might interfere with or fall upon the lines or systems of communications or power transmission or distribution; and further grants, to the fullest extent the undersigned has the power to grant, if at all, the rights hereinabove granted on the Easement Area heretofore described, over, along, under and across the roads, streets or highways adjoining or through said Easement Area.


