## ORDINANCE NO. C-19-14

AN ORDINANCE AMENDING CHAPTER 24, SOLID WASTE, SECTION 24-47, CHARGES GENERALLY, OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE, FLORIDA, TO INCREASE THE SOLID WASTE CHARGES AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale (hereinafter "City") provides municipal solid waste collection and disposal services in furtherance of the health, safety and welfare of its residents; and

WHEREAS, the City's costs for providing solid waste collection and disposal services have increased since the last rate adjustment in October of 2018; and

WHEREAS, an increase in the schedule of rates and charges for garbage and trash collection, disposal and operating is necessary to offset the increased cost of providing the service:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That Section 24-47 – Charges generally, Division 2. Rates and Charges, Chapter 24. – Solid Waste of the Code of Ordinances of the City of Fort Lauderdale, Florida, is amended to read as follows:

Sec. 24-47. - Charges generally.

There is hereby established and levied a schedule of rates and charges for garbage and trash collection, disposal, and operating costs, hereafter referred to as the solid waste rate as depicted in Table 1, below:
