TITLE: Motion Approving Donation to R&R Domestic Services, Inc. from State Law

Enforcement Trust Fund - \$5,000 - (Commission Districts 1, 2, 3 and 4)

#### **Recommendation**

It is recommended that the City Commission approve a donation to R&R Domestic Services, Inc. in the amount of \$5,000 utilizing State Law Enforcement Trust Fund.

### **Background**

R&R Domestic Services, Inc. is a Broward County based 501(c)3 non-profit charitable organization founded in 1998. The organization is devoted to assisting law enforcement in the reduction of domestic violence incidents through the delivery of Batterer's Intervention and Anger Management classes to both adjudicated and non-adjudicated individuals. The mission of R&R Domestic Services is to foster peaceful relationships in families and communities by increasing self-awareness, challenging abuse and control, teaching alternative behaviors and promoting personal and social responsibility. Classes are held weekly in the City of Fort Lauderdale targeting at-risk males focusing on creating a safer environment. By early intervention, this model serves to have a positive effect on numerous families in the City.

# **Resource Impact**

There is a fiscal impact to the Police Department's State Trust Fund in the amount of \$5,000. This item is contingent upon the approval of a concurrent Consolidated Budget Amendment.
