Dr. Pittman, President of the Historical Dorsey Riverbend Civic Association introduced Ms. Romanik to the audience.

The Architectural Site Plan, Floor Plans and Renderings were presented through a PowerPoint format. A floor-by-floor walkthrough of program spaces was shared. Topics of discussion included Pedestrian and Vehicular Access to the Site and Building, including the Existing Public Transportation on Sistrunk which includes an existing Bus Lane to remain.
