**TITLE**: Motion Approving the 2019-2020 State Housing Initiatives Partnership

Program (SHIP) and Amend the 2018-2019 SHIP Funds Program Income

(Commission Districts 1, 2, 3 & 4)

## **Recommendation**

It is recommended that the City Commission pass a motion accepting the 2019-2020 State Housing Initiatives Partnership (SHIP) program funds in the amount of \$248,157 permitting staff to use up to 10% of SHIP funds for administrative costs, and as program income is earned, set aside up to 5% for administrative costs; revising the 2018-2019 SHIP Program Income and authorizing the City Manager to execute all documents related to the acceptance of the 2019-2020 award and revision of the 2018-2019 award respectively.

### **Background**

The SHIP Program administered by Florida Housing Finance Corporation (FHFC) has appropriated \$45,060,000 in funding for the 2019-2020 fiscal year. The City of Fort Lauderdale will receive \$248,157 (Exhibit 1) to be used for affordable housing strategies as per the approved 2019-2022 Local Housing Assistance Plan (LHAP) CAM #19-0224. In addition to the award of \$248,157, the estimated program income for FY 2019-2020 will be \$100,000 and estimated program interest will be \$25,000. Total amount available for FY 2019-2020 will be \$373,157.

The funding requirements are as follows:

 A minimum of 20% of allocated SHIP funds be used to serve special needs persons with a priority to serve persons with developmental disabilities as defined in section 420.004, Florida Statutes.

AHAC and Housing and Community Development staff are making the following recommendations for the allocation of the \$248,157 for FY 2019-2020 SHIP funding:

- 1. Purchase Assistance \$143,709.90
- 2. Project Service Delivery Costs \$30,000.00

- 3. Special Needs \$49,631.40
- 4. Administration \$24,815.70

Revisions to the 2018-2019 SHIP funding include an estimated additional program income (PI) in the amount of \$46,208 and interest in the amount of \$49,767 for 2018-2019 from repayment of SHIP loans. Total amount available PI funds from FY 2018-2019 will be \$95,975.

Additionally, Housing and Community Development staff recommend that any program income be expended for strategies in the 2019-2022 LHAP including but not limited to the Owner Occupied Rehabilitation, Purchase Assistance without rehabilitation and the Rapid Re-Housing Strategies.

# **Resource Impact**

Funding for this item is contingent upon the approval of the Consolidated Budget Amendment CAM# 19-0258.
