TITLE: Motion to Approve a Contract for Bennett Elementary Playground

Replacement Project - Maceda Contractors, LLC. - \$213,000 -

(Commission District 2)

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the Bennett Elementary Playground Replacement Project with Maceda Contractors, LLC. ("Maceda") in the estimated amount of \$213,000.

Background

The scope of work includes, but is not limited to, the construction of two new playgrounds (for age groups of 2-5 and 5-12); new chain link fencing with gates; new full size basketball court and striping; new rolling hill sodded play mounds; and new site amenities as per the plans and specifications.

On May 1, 2019, the City's Procurement Services Division issued Invitation to Bid (ITB) No. 12284-293 for the Bennett Elementary Playground Replacement Project. A total of three bids were received on June 11, 2019 from the following vendors:

- Maceda for \$213,000
- Sagaris Corp. for \$241,000
- Leadex Corporation. for \$250,860

Two of the three vendors that responded are either a Minority Owned Business Enterprise, Women Owned Business Enterprise, or Small Business Enterprise. The bids were reviewed for compliance with the solicitation specifications. The bid submitted by Maceda has met all of the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bid. Staff recommends awarding the contract to Maceda.

Reference checks for Maceda were all in compliance with City standards.

Resource Impact

There will be a fiscal impact to the City in the amount of \$213,000 for the contract award with the allowances included and \$37,000 for estimated in-house project management fees for a total of \$250,000. Funds for this purchase in the total amount of \$250,000 are available in the account listed below.
