#### **CALL TO ORDER**

Chair Trantalis called the meeting to order at 4:24 p.m.

#### **BOARD REPORTS**

#### **BR-1** 19-0789

Central Beach Master Plan Public Improvement Projects Update - (Commission District 2)

In response to Chair Trantalis' question, Don Morris, Economic and Beach Redevelopment Area Manager - Beach Area Community Redevelopment Agency, confirmed that the Las Olas Boulevard and the Oceanside Park area would be functional by October 31, 2019. He noted punch list items for the Park and commented on a ribbon cutting ceremony related to the projects.

In response to Commissioner Glassman's question regarding having a graphics policy for wrapping the trolley vehicles that will be used to transport people from the Las Olas Parking Garage to the beach, Mr. Morris confirmed the vehicles are in place but a policy for the graphics has not been addressed.

In response to Commissioner Glassman's question regarding the timeline for D.C. Alexander Park, Mr. Morris explained that the design concept is moving towards thirty percent (30%). When the thirty percent (30%) design concept is reached, it will be presented at a joint meeting with the Beach Redevelopment Board and the Parks, Recreation and Beaches Board. Commissioner Glassman confirmed that the CRA Board requested a thirty percent (30%) design concept presentation.

In response to Commissioner Glassman's question regarding an update on the Aquatic Complex, previous delays involving Florida Power and Light (FPL) utility matters and staging readiness for The Boat Show, Mr. Morris confirmed readiness for The Boat Show. Thomas Green, CRA Senior Project Manager, confirmed ongoing efforts to be more efficient to make up for past FPL related delays. He also confirmed that there should be no impact on The Boat Show with regard to previous FPL matters. Further comment and discussion ensued on the timeline for Aquatic Complex completion. Mr. Morris said he would report back to the Board with an update on the estimated timeline for completion.
