TITLE: Motion Terminating for Convenience Contract No. 373-11879 for Special

Event Clean-Up Services and Approve New Contract for Same Services – BACM Solution Services LLC - \$124,879 – (Commission Districts 1, 2,

3, and 4)

Recommendation

It is recommended that the City Commission terminate for convenience Contract No. 373-11879 for special event clean-up services from Weed-A-Way, Inc. and approve a new, one-year contract, in substantially the form attached, for the same services from BACM Solution Services LLC, in the estimated annual amount of \$124,879 and authorize the City Manager to approve three one-year renewal options, contingent upon appropriation of funds.

Background

On February 7, 2017, a two-year contract for special event clean-up services was administratively awarded to Weed-A-Way, Inc. The contract was administratively renewed for a one-year term which expires on February 6, 2020. The purpose of this contract is to provide special event clean-up services which include day and nighttime personnel and equipment. Services include, but are not limited to, management, supervision and labor in collecting and disposing of recyclables, garbage, trash and litter from special events scheduled or coordinated by the City's Parks and Recreation Department. Due to the recent expansion of special events, the scope of services on the current contract with Weed-A-Way, Inc. has doubled, requiring these services to be rebid.

The Procurement Services Division issued Invitation to Bid No. 12320-593 and received six bids. Four of the six vendors that responded are a Minority Owned Business Enterprise, Women Owned Business Enterprise, or Small Business Enterprise. The bid submitted by BACM Solution Services LLC has met all of the specifications of the bid and has been deemed the lowest cost, responsive and responsible bidder.

Resource Impact

There will be no fiscal impact to the City for Fiscal Year 2019. There will be a fiscal impact in FY20 in the amount of \$124,879 for the contract award as indicated below. Future year expenditures are contingent upon approval of those fiscal year annual budgets.
