

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida (the "City Commission") enacted Ordinance No. C-13-14 on June 4, 2013 (the "Wave Ordinance"), and adopted Resolution Nos. 13-95 and 13-131 on June 4, 2013 and July 9, 2013, respectively (the "Wave Assessment Resolutions"), pursuant to which the Wave Streetcar Assessment Area was established and special assessments (the "Wave Assessments") were authorized to be imposed against assessable property located within the Wave Streetcar Assessment Area specially benefitted by the Wave Project in order to satisfy certain financial obligations of the City of Fort Lauderdale, Florida (the "City") in connection with the Wave Modern Streetcar Project (the "Wave Project"); and

WHEREAS, on December 18, 2012, in anticipation of enacting the Wave Ordinance and adopting the Wave Assessment Resolutions, the City Commission adopted Resolution No. 12-241 expressing the City's intent to use the uniform method of collecting non-ad valorem special assessments authorized by Section 197.3632, Florida Statutes, as amended, for the collection of the Wave Assessments within the Wave Streetcar Assessment Area, and said Resolution No. 12-241 provided a legal description of such area subject to the Wave Assessment, which legal description is attached hereto as Exhibit A and incorporated herein by reference; and

WHEREAS, said Resolution No. 12-241 was recorded in Official Record Book 49431, Page 825 of the Public Records of Broward County, Florida and continues to appear as an encumbrance upon the assessable properties within the Wave Streetcar Assessment Area; and

WHEREAS, from 2013 through 2017, pursuant to the Wave Ordinance, the Wave Resolutions and certain annual assessment resolutions, to wit: Resolution No. 14-148 adopted on September 10, 2014, Resolution No. 15-194 adopted on September 8, 2015, Resolution No. 16-154 adopted on September 12, 2016 and Resolution No. 17-197 adopted on September 13, 2017 (collectively, the "Annual Assessment Resolutions"), the City Commission imposed the Wave Assessments on assessable properties within the Wave Streetcar Assessment Area; and

WHEREAS, in 2018, the City and the other parties to the various Wave Project-related agreements decided to cancel and terminate the Wave Project and the City Commission decided to refund the Wave Assessments paid since 2013 to the persons lawfully entitled to receive such refunds, all as more specifically provided for in Resolution No. 19-30 adopted by the City Commission on February 19, 2019 (the "Wave Project Termination Resolution") and Resolution No. 19-54 adopted by the City Commission on March 19, 2019 (the "Wave Assessments Refund Resolution") respectively; and

WHEREAS, as a result of the cancellation and termination of the Wave Project, the City Commission did not impose a Wave Assessment for the fiscal year commencing October 1, 2018, and the City Commission does not intend to impose Wave Assessments in any future fiscal year; and

WHEREAS, as a result of the cancellation and termination of the Wave Project, it is appropriate to discontinue and terminate the Wave Assessments and to remove any and all liens or encumbrances on the assessable properties within the Wave Streetcar Assessment Area related to or resulting from the Wave Assessments or any of the Wave Ordinance, the Wave Assessment Resolutions or the Annual Assessment Resolutions (collectively, the "Wave Assessment Legislation");

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. INCORPORATION OF RECITALS. The foregoing "WHEREAS" clauses are hereby incorporated into this Resolution by this reference.

SECTION 2. AUTHORITY. This Resolution is adopted pursuant to Article VIII, Section 2, Florida Constitution, Sections 166.021 and 166.041, Florida Statutes, and other applicable provisions of law.

SECTION 3. DEFINITIONS. All capitalized terms not otherwise defined in this Resolution shall have the meanings ascribed to them in the Wave Assessment Legislation.

SECTION 4. REPEAL OF RESOLUTION NO. 12-241. As a result of the cancellation and termination of the Wave Project, and in order to release assessable properties within the Wave Streetcar Assessment Area from any lien or encumbrance created by Resolution No. 12-241, said Resolution No. 12-241 is hereby repealed and shall be of no further effect. The assessable properties within the Wave Streetcar Assessment Area, as more specifically described in the Wave Project Termination Resolution and the Wave Assessments Refund Resolution, are hereby released from any lien or encumbrance created by said Resolution No. 12-241.

SECTION 5. DISCONTINUATION AND TERMINATION OF WAVE ASSESSMENTS. Consistent with the cancellation and termination of the Wave Project, the City Commission hereby discontinues and terminates the Wave Assessments in the current and all future fiscal years. The assessable properties within the Wave Streetcar Assessment Area, as more specifically described in the Wave Project Termination Resolution and the Wave Assessments Refund Resolution, are hereby released from any lien or encumbrance created by the Wave Assessment Legislation related to or resulting from the Wave Assessments:

<u>SECTION 6</u>. RECORDING OF THIS RESOLUTION. As soon as practicable after its adoption, this Resolution shall be submitted for recording in the official record books of Broward County, Florida.

SECTION 7. GENERAL AUTHORITY The members of the City Commission, the City Manager, the City Attorney, the Finance Director, the City Clerk and the officers, attorneys and other agents or employees of the City are hereby authorized to do all acts and things required of them by this Resolution or desirable or consistent with the provisions of this Resolution for the full, punctual and complete performance of all the provisions contained herein, and each member, employee, attorney and officer of the City Commission, the City Manager, the City Attorney, the Finance Director and the City Clerk is hereby authorized and directed to execute and deliver any and all papers and instruments and to do and to cause to be done any and all

acts and things necessary or proper for carrying out the transactions contemplated by this Resolution or to give effect to the provisions hereof.

SECTION 8. SEVERABILITY. If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and in no way affecting the validity of the other provisions of this Resolution.

<u>SECTION 9</u>. CONFLICTS. Any resolutions or parts of resolutions in conflict herewith shall be and the same are repealed to the extent of such conflict.

SECTION 10. EFFECTIVE DATE. This Resolution shall take effect immediately upon its passage and adoption.
