4.2.3 Experience and Qualification

MCL was founded in 2008 to bring imaginative and innovative designs and superior décor management to the holiday industry in South Florida. Having serviced thousands of municipal and commercial properties around the state over the years, we are excited to begin our 12th season of installing and looking forward to developing world-class décor and providing superior holiday decor services to our clients! MCL has the experience and capabilities to provide the holiday decor scope of work requirements as stated in the RFP for the City of Fort Lauderdale CRA in the Sistrunk area.

Below are some details of past and present projects for agencies of similar size and scope, including information on MCL's ability to meet time and budget requirements:

Town of Surfside

Project Description and Scope:

The Town of Surfside has been a client of MCL's for the past 5 years, awarding MCL 2 competitively bid contracts. Their project is unique in the fact that they have over 150 trees that are illuminated in a 2 block radius. To add additional complications to the project, their contractor is only able to install and remove the lights in the evening hours due to the intense pedestrian traffic in the area.

MCL rose to the occasion by micro organizing the installation, calculating the time for each tree and the number of staff to execute the project flawlessly. Our original projections included a 3 day installation period, but do to the success of our Operations Account Manager, proactive planning and proprietary installation management software were able to complete the installation in just one and a half shifts, 50% faster than expected. Reducing the installation time, saved the city additional monies in shutting down the street with police as well as inconvenience to the Town.

The Town's display created widespread buzz and many municipalities have referenced it in their own RFPs as well as called MCL directly due to the success of the project. The lights have a 98.7% illumination rate without any additional required maintenance. Gulfstream Park

Providing the 50' RGB holiday tree with syncing musical programs and lighting shows is a challenging task to

MCL has technical teams as well as numerous trucks, lift trucks and other equipment. Our plan will include doing all scheduled installs during the overnight hours to minimize impact on traffic on Sistrunk Ave. The installation will be overseen by our President, Kurt Stange, Director of Design and Fabricaton, Edwin Santa, supervised in the field by the Operations Account Manager, Rashad Delancy, and managed by Operations Manager, Carlos Socorro. As the installation is progressing, the MCL team will be in communication with personnel from the City to make sure all work is completed with minimal interference with the daily traffic of the area. Once the installation is completed, our maintenance team will check the display to ensure everything is working properly.

Maintenance
