Approving Contract for Purchase of Vehicle Graphics, Installation and Removal Services – Signamerica, Inc. – \$594,876 (estimated three-year

total) - (Commission Districts 1, 2, 3 and 4)

Recommendation

It is recommended that the City Commission reject all bids for Invitation to Bid ("ITB") 12297-893 - Vehicle Graphics, Installation and Removal and approve a three-year contract, in substantially the form attached, with Signamerica, Inc. ("SI") for purchase of vehicle graphics, installation and removal services in the estimated three-year total of \$594,876, and authorize the City Manager to approve two additional one-year renewal options contingent upon appropriation of funds.

Background

On June 18, 2019, the Procurement Services Division issued an initial solicitation for vehicle graphics, installation and removal services with ITB No. 12297-893. After bids were received, staff noticed that necessary items were inadvertently omitted from the bid and the requested services would have to be re-bid. On July 23, 2019, a new ITB, No. 12317-893 - Vehicle Graphics, Installation and Removal - Re-Bid was issued and included all necessary items and services.

On August 13, 2019, the City received five bids; two of which are either a Minority - Owned Business Enterprise, Women-Owned Business Enterprise, or Small Business Enterprise. The bid from SI has met all of the specifications of the bid and has been deemed the lowest cost, responsive, and responsible bidder.

Resource Impact

There will be a fiscal impact in the amount of \$198,292 for the contract award. Future expenditures are contingent upon approval and appropriation of future year annual budgets.
