## **RESOLUTION NO. 19-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, REGARDING THE APPEAL OF THE PLANNING AND ZONING BOARD'S DENIAL OF THE REZONING OF CERTAIN PROPERTY LOCATED AT  $6^{\text{TH}}$ NORTHWEST AVENUE FROM 816 GENERAL INDUSTRIAL (I) TO GENERAL BUSINESS (B-2), MORE PARTICULARLY DESCRIBED HEREIN, MAKING CERTAIN FINDINGS AND SETTING A DE NOVO HEARING TO CONSIDER THE APPEAL BEFORE THE CITY COMMISSION AT 6:00 P.M. ON NOVEMBER 5, 2019, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on May 15, 2019, the Planning and Zoning Board (PZ Case No. Z19002) denied a request for rezoning of certain property located at 816 Northwest 6<sup>th</sup> Avenue from General Industrial (I) to General Business (B-2); and

WHEREAS, Section 47-24.4.H of the City of Fort Lauderdale, Florida Unified Land Development Regulations ("ULDR") provides that the applicant may file an appeal to the City Commission in accordance with Section 47-26B - Appeals; and

WHEREAS, in accordance with Section 47.26B, the City Commission has reviewed the record at its November 5, 2019 regular meeting and determined that either there was a departure from the essential requirements of law in the proceedings or that competent substantial evidence does not exist to support the decision of the Planning and Zoning Board; and

WHEREAS, the City Commission will conduct a de novo hearing on the rezoning application;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed.

<u>SECTION 2</u>. The de novo hearing and first reading of an ordinance rezoning of certain property located at 816 Northwest 6<sup>th</sup> Avenue, more particularly described as:

At such time and place, the City Commission shall consider whether or not it intends to approve, amend or reject the decision of the Planning and Zoning Board.
