TITLE: Motion Approving Contract for the Sweeting Park Dock Replacement Re-Bid Project – Sun Eagle General Contractors Corporation - \$217,440 -
(Commission District 3)

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for Sweeting Park Dock Replacement Re-Bid Project with Sun Eagle General Contractors Corporation, in the amount of \$217,440.

Background

This Project is for the construction of one new fishing/viewing dock over the North Fork of the New River at Sweeting Park located at 433 NW 23rd Avenue, Fort Lauderdale. This dock replaces two previously demolished docks that were in disrepair and a hazard to our residents.

On June 19, 2019, the Procurement Services Division issued Invitation to Bid (“ITB”) No. 12282-693. Four bids were received on July 31, 2019, and the bids were reviewed for compliance with the solicitation specifications. None of the four bidders indicated that they are a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise. Sun Eagle General Contractors Corporation submitted the lowest bid in the amount of \$103,440 plus \$109,000 for Alternate #1 for the ramp and decking to be constructed with recycled plastic lumber and \$5,000 in permit allowances for a total of \$217,440.

Reference checks for Sun Eagle General Contractors Corporation were all in compliance with City standards. The bid submitted by Sun Eagle General Contractors Corp. has been deemed the lowest, responsive, and responsible bidder. Staff recommends awarding the base bid in the amount of \$103,440 plus \$109,000 for Alternate #1 for the ramp and decking to be constructed with recycled plastic lumber and \$5,000 in permit allowances for a total of \$217,440.

Resource Impact

There will be a fiscal impact to the City in the amount of \$217,440 for the contract award

including allowances and \$38,990 for estimated in-house project management fees for a total of \$256,430. Funds for this contract in the total amount of \$150,430 are available in the FY 2020 Community Investment Plan in the account listed below with \$106,000 contingent upon the approval of budget amendment CAM #19-1064.
