TITLE: Motion Authorizing Execution of a Revocable License with The Las Olas

Holding Company, Inc. for the Installation and Maintenance of a Compactor and Dumpster within the Heron Parking Lot Located at 216 SE 8 Avenue –

(Commission District 4)

Recommendation

It is recommended that the City Commission authorize the execution of a revocable license agreement with The Las Olas Holding Company, Inc. (Licensee) for the placement of a compactor and recycling dumpster at the southeast corner of the Heron Parking Lot located at 216 SE 8 Avenue.

Background

Representatives of The Las Olas Holding Company, Inc. approached the Transportation and Mobility Department staff with a request to facilitate the use of approximately 250 SF within the City's Heron Parking Lot (Exhibit 1) for the nonexclusive possession, use, construction, and installation of a trash compactor and recycling dumpster. The Las Olas Holding Company, Inc. needs additional trash and recycling capacity for the businesses in the area.

The proposed revocable license term will be for a five-year period, the starting annual fee is \$3,500 with three percent annual increases, and one option to renew for an additional five-year term. The Licensee will submit plans and specifications for the project, no construction shall commence prior to the issuance of the required permits. As part of the improvements the Licensee will widen the entrance lane into the parking lot in coordination and compliance with all City regulations and input with the Transportation and Mobility Department. The Licensee agrees that all trash collection shall occur between the hours of 5:00 AM to 7:00 AM to minimize the impact on parking patrons.

Resource Impact

There will be a positive impact of \$3,500 with three percent annual increases for FY 2020 to the Parking Fund.
