- TITLE: Resolution Approving the Fourth Amendment to the Interlocal Agreement with the Downtown Fort Lauderdale Transportation Management Association, Inc. for Community Bus and Transit Services - (Commission Districts 1, 2, 3, and 4)

## **Recommendation**

It is recommended that the City Commission adopt a resolution authorizing the City Manager to execute a Fourth Amendment to the 2014 Interlocal Agreement between the City of Fort Lauderdale and the Downtown Fort Lauderdale Transportation Management Association, Inc., in substantially the same form.

### **Background**

The Downtown Fort Lauderdale Transportation Management Association, Inc. (TMA) operates the City of Fort Lauderdale's (City) community bus service, otherwise known as the Sun Trolley and Riverwalk Water Trolley, under a 2014 Interlocal Agreement (ILA) with the City which expires on March 30, 2020 (Exhibit 1). Previous amendments to the ILA include:

•	Amendment 1: April 20, 2015	Added Uptown Link Service
•	Amendment 2: October 9, 2018	Amended "Term and Time of Performance" and "Scope of Services" language. Extended term for one year to September 30, 2019.
•	Amendment 3: September 19, 2019	Extended the term for six months to March 30, 2020. Updated routes and vehicles.

This proposed Fourth Amendment (Exhibit 2) adds the new *Seabreeze* tram route, which connects the Las Olas Parking Garage and the new Oceanside Park on State Road A1A (Exhibit 4). Using two trams purchased by the Beach Community

Redevelopment Agency and owned by the City (Exhibit 3), the TMA will operate the service and provide drivers and administration. City staff will provide vehicle maintenance, cleaning, repairs and fueling.

The *Seabreeze* tram will begin operating in November 2019, coinciding with the completion of the Oceanside Park, with the following operating schedule:

At its meeting on October 23, 2019, the Downtown Fort Lauderdale Transportation Management Association Board of Directors approved the proposed Fourth Amendment.

### Resource Impact:

The estimated Parking Fund financial impact of operating the Seabreeze tram is approximately \$200,000 including the TMA operating, tram maintenance and fueling costs. The financial impact of this amendment is for the TMA operating cost in the amount of \$125,000. This funding was approved on October 2, 2019 with CAM #19-0847. There will be no farebox revenue as this will be a free service.
