TITLE:	Motion Approving Contract for the Fort Lauderdale Executive Airport Taxiway Foxtrot Relocation Project – General Asphalt Co., Inc. – \$7,700,001 – (Commission District 1)

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the Fort Lauderdale Executive Airport Taxiway Foxtrot Relocation Project with General Asphalt Co., Inc., in the amount of \$7,700,001.

Background

The Federal Aviation Administration ("FAA") reviewed the current Airport Layout Plan and determined that the eastern portion of Taxiway Foxtrot does not meet the taxiway centerline separation requirement. The taxiway is located 305 feet from the centerline of Runway 9-27, instead of the required 400-feet distance. In order to comply with current taxiway separation criteria, the FAA recommended that the eastern portion of the taxiway be relocated.

This Project includes the demolition of 3,200 linear feet of taxiway pavement, including lights and guidance signs, as well as the construction of a new asphalt paved taxiway, including grading, subgrade, limerock base course, pavement striping, new taxiway edge-lights, and guidance signs. The existing aircraft run-up apron will be demolished and a new run-up area will be constructed to meet current FAA design standards.

On April 26, 2019, the Procurement Services Division issued Invitation to Bid No. 12277-693. Four bids were received on June 20, 2019, and the bids were reviewed for compliance with the solicitation specifications. None of the four vendors that responded have indicated their status as a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise. The bid submitted by General Asphalt Co., Inc. is the lowest cost, responsive, and responsible bidder recommended for award.

Resource Impact

There will be a fiscal impact to the City in the amount of \$7,700,001 for the contract award and \$97,440 for estimated in-house project management fees, for a total of

\$7,797,441. Funds for this award, in the amount of \$7,797,441 are available in the FY2020 Community Investment Plan in the accounts listed below.
