TITLE: Motion Approving a Contract for George English Park Boat Ramp

Renovation Project to Sagaris Corp. – \$991,945 – (Commission District

1)

Recommendation

It is recommended that the City Commission award a contract, in substantially the form attached, for the George English Park Boat Ramp Renovation Project No. 12186 with Sagaris Corp., in the amount of \$991,945.

Background

The George English Park boat ramp, located at 1101 Bayview Drive, was originally designed to serve smaller watercraft due to height restrictions of the Sunrise Boulevard Bridge. The existing boat ramps consist of articulated concrete tiles that continually dislodge and give way, creating potholes and other safety hazards limiting safe use of the ramps. The newly constructed Sunrise Boulevard Bridge provides increased height access to larger vessels that cannot be serviced at the existing boat ramps.

This project includes the removal of the existing docks, new pilings, four new floating docks at the two boat ramps, and sidewalk replacement. The boat ramps will provide access for persons with disabilities and be suitable for the launching of larger vessels. Final project completion is due within 180 days of the date specified in the Notice to Proceed.

On July 23, 2019, the Procurement Services Division issued Invitation to Bid No. 12298-693. Six bids were received on September 12, 2019. None of the six vendors that responded indicated that they are a Minority-Owned Business Enterprise, Women-Owned Business Enterprise or Small Business Enterprise.

All bids were reviewed for compliance with the solicitation specifications. Based on the review, the bid submitted by Sagaris Corp. was deemed the lowest most responsive and responsible bidder.

Resource Impact

There will be a fiscal impact to the City in the amount of \$991,945 for the base bid contract award plus allowances and \$60,000 for estimated in-house project management fees, for a total project cost is \$1,051,945. Funds for this contract in the amount of \$1,051,945 are available in the FY2020 Community Investment Plan in the accounts listed below.
