TITLE: Motion Approving Contract for Purchase of Roofing Maintenance and

Repairs - Advanced Roofing, Inc. - \$3,000,000 (estimated three-year

total) - (Commission Districts 1, 2, 3 and 4)

Recommendation

It is recommended that the City Commission approve a three-year contract, in substantially the form attached, for the purchase of roofing maintenance and repairs, from Advanced Roofing, Inc. via the City of Sunrise Contract No. 19-17-12-HR for an estimated three-year amount of \$3,000,000 and authorize the City Manager to approve three one-year renewal options, contingent upon appropriation of funds.

Background

This contract will be used for roof repairs and replacement to the City's building inventory. In Fiscal Year 2019, the City spent \$823,273.81 for roof replacements and roofing repairs.

Pursuant to Section 2-181(f)(5)b., Code of Ordinances of the City of Fort Lauderdale, the City may piggyback a contract entered into by another governmental or public entity and a provider of supplies or services required by the City, if the chief procurement officer determines that it is practicable and advantageous for the City to employ this method of procurement. The chief procurement officer has determined that it would be practicable and advantageous for the City to use this method of procurement for this agreement. This purchase will be made in accordance with City of Sunrise Contract No. 19-17-12-HR from Advanced Roofing, Inc. in the amount of \$3,000,000.

Resource Impact

There will be a current FY fiscal impact in the amount of \$1,000,000 for this item. Funds for this agreement are available in the FY 2020 Budget/CIP account listed below:
