**TITLE**: Motion Approving Contract for River Oaks Preserve Project – Continental

Construction USA, LLC – \$1,523,086 – (Commission District 4)

### Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the River Oaks Preserve Project with Continental Construction USA, LLC ("Continental"), in the amount of \$1,523,086.

### **Background**

The River Oaks Preserve consists of 9.1 acres of land area that the City acquired with the intention of constructing a stormwater preserve park for the public. The park will feature wetlands, an elevated boardwalk, and a historic bascule bridge donated by the Florida Department of Transportation ("FDOT") that will be converted into a pedestrian boardwalk. This project will construct approximately 600 feet of elevated boardwalk made out of wood, or an approved equal material, along the northern side of the project site. The elevated boardwalk will be connected to the existing CSX bascule bridge abutment and contain an educational gazebo (constructed by FDOT).

The stormwater preserve park area will consist of a combination of elevated tree islands, wetlands, bio-swales and drainage structures designed to provide water quality treatment of stormwater runoff from the River Oaks neighborhood area before discharging into the South Fork New River. The preserve will also serve as an educational showcase and provide a much needed recreational green space for the River Oaks community residents.

On August 22, 2019, the Procurement Services Division issued Invitation to Bid No. 12242-493. The City received six bids in response to the solicitation, which were opened on October 3, 2019. One of the six vendors that responded indicated they are either a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise. All bids were reviewed for compliance with the solicitation specifications. The bid submitted by Continental has met all the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bid.

#### **Resource Impact**

There will be a fiscal impact to the City in the amount of \$1,523,086 for the contract award with the allowances included and \$140,000 for estimated in-house project management fees, and \$90,000 for construction engineering and inspection costs. The estimated project total is \$1,753,086. Funds for this contract in the total amount of \$745,957 are available in the FY2020 Community Investment Plan in the accounts listed below with \$1,007,129 contingent upon the approval and appropriation of the consolidated budget amendment CAM #19-1222 on January 7, 2020.
