TITLE: Motion Authorizing an Excess Payment of \$71,528.97 in Utility and

Service Charges in Accordance with the Performing Arts Center Authority

Lease Agreement – (Commission District 2)

Recommendation

It is recommended that the City Commission approve a motion authorizing an excess payment of \$71,528.97 in utility and service charges pursuant to Section 3.5 of the Performing Arts Center Authority Lease Agreement.

Background

On February 6, 2018, the City Commission approved an assignment of a 50-year lease for City-owned property located at 707 NE 8 Street, also known as the Parker Playhouse Theatre, with the Performing Arts Center Authority ("PACA"). PACA is renovating and rehabilitating the improvements on the leased premises. Architectural and engineering designs began in 2017 and on-going construction is estimated to be completed by December 2021. Pursuant to Section 3.5 – Utility or Service Charges of the Lease, in the event the annual fees for utility and service charges exceed \$15,000 in any fiscal year, the Lessee has the right to submit a written request for reimbursement.

On November 19, 2019, PACA submitted a request for reimbursement for \$71,528.97. As stipulated in the lease agreement the City Manager has the authority to reimburse up to \$50,000 an amount exceeding \$50,000 will have to be approved by the City Commission.
