**TITLE:** Resolution Approving a Locally Funded Agreement and an Escrow Agreement with Florida Department of Transportation for SR A1A and SE 5<sup>th</sup> Street Traffic Signal Trombone Mast Arms - \$22,379 - **(Commission District 2)**

**Recommendation**

It is recommended that the City Commission adopt a resolution authorizing the City Manager to execute a Locally Funded Agreement and an Escrow Agreement in substantially the form attached in Exhibits 1 and 2 with the Florida Department of Transportation in the amount of \$22,379 for the installation of two black powder-coated trombone mast arms at SR A1A and SE 5<sup>th</sup> Street.

**Background**

The Florida Department of Transportation (FDOT) performed an assessment of the trombone mast arm at the intersection of SR A1A and SE 5<sup>th</sup> Street and determined that the east bound mast arm needed to be replaced. FDOT will be replacing the existing trombone mast arm with two mast arms of its standard product, which will not aesthetically match the other mast arms at this intersection and along SR A1A. The City can enter into a locally-funded agreement with FDOT to powder-coat the new mast arms to match the other signals on A1A throughout the barrier island.

FDOT has programmed the installation of the permanent black powder-coated trombone mast arms for March 2020 at which time the signal will be activated and SE 5<sup>th</sup> Street will be configured into a permanent two-way condition.

**Resource Impact**

The resource impact to the City is in the amount of \$22,379.00 based on the quote provided by FDOT's contractor.
