**TITLE**: Motion Approving Purchase of Portable Stage – Century Industries, LLC -

\$104,771- (Commission Districts 1, 2, 3, and 4)

#### Recommendation

It is recommended that the City Commission approve the purchase of a portable stage from Century Industries LLC, via the City of Coconut Creek's Contract No. 08-14-19-11 for an estimated expenditure of \$104,771.

## **Background**

The City owns a portable stage that is used by Parks and Recreation for over thirty City events throughout the year. Examples of such events include the Sistrunk Festival, the Great American Beach Party, 4<sup>th</sup> of July Celebration, and the Starlight Musical series. The stage is also a revenue generator as it is rented to outside groups for non-city events. The current stage is past its useful life cycle and is scheduled for replacement in FY2020 which is consistent with the Five-Year Fleet Replacement Plan. This purchase is necessary to replace unit V5528, a 2005 portable stage.

Pursuant to Section 2-181(f)(5)(b), Code of Ordinances of the City of Fort Lauderdale, Florida, the City may participate in a contract entered into by another governmental or public entity and a provider of supplies or services required by the City, if the chief procurement officer determines that it is practicable and advantageous for the city to employ this method of procurement. The chief procurement officer has determined that it would be practicable and advantageous for the city to use this method of procurement for this agreement. This purchase for a portable stage will be made in accordance with RFP No. 08-14-19-11 from the City of Coconut Creek from Century Industries LLC in the amount of \$104,771.
