Resolution Approving Lease Agreement with Terminal Ventures, LLC for Parcel 8G at Fort Lauderdale Executive Airport - (Commission District 1)

Commissioner Moraitis requested input from the parties.

Mayor Trantalis recognized Rufus James, Fort Lauderdale Executive Airport (FXE) Manager. Mr. James gave a brief overview of details regarding this item.

Mayor Trantalis recognized Matthew Morrall, 2600 NE 21st Street, on behalf of the JM Family. He gave a brief overview of discussions with JM Family Southeast Toyota (JM), representatives of W Aviation, LLC (W

Aviation) and FXE (stakeholders), commenting on related details. Mr. Morrall requested a two-week delay, allowing the opportunity for stakeholders to work out a solution.

Mayor Trantalis recognized Ignacio Martinez, President of W Aviation. Mr. Martinez noted discussions with members of the Commission and explained details regarding expansion of W Aviation's Fixed Base Operations (FBO) through Terminal Ventures, LLC's leasing of this building. He discussed the need to be operational by *Super Bowl Weekend* and previous negotiations with representatives of JM. The building would remain as is, existing easements would be maintained and the existing ingress and egress ramp to W Aviation's FBO would remain. Mr. Martinez said their goal is to provide an improved passenger experience, citing the addition of two hangars and the need for an improved terminal to accommodate W Aviation clients. He explained details regarding previous efforts to provide an alternative route for JM's adjacent business.

Vice Mayor McKinzie arrived at 6:30 p.m.

In response to Mayor Trantalis' question, Mr. Martinez confirmed the building would provide a service terminal for W Aviation customers.

In response to Mayor Trantalis' questions, Mr. James confirmed W Aviation is investing \$1,500,000 to rehabilitate this vacant building. Mr. James and Mr. Morrall briefly commented on the effect this item would have on the adjacent JM parcel. Further comment ensued.

City Attorney Alain Boileau commented on challenges previously discussed in a stakeholder meeting related to the incorporation of items into the lease that would address pedestrian flow. Further comment and discussion ensued.

Commissioner Moraitis urged the parties to work together over the next two weeks to come to an agreement. City Attorney Boileau reconfirmed the inability to include third-party terms into the lease with W Aviation.

In response to Commissioner Sorensen's question, Mr. Morrall commented on JM's desire to come to a satisfactory agreement with W Aviation.

Mr. Martinez confirmed the willingness of W Aviation to participate in discussions, emphasizing the economic impact of not having a lease in place prior to *Super Bowl Weekend*, expounding on related details.

Mayor Trantalis noted the economic impact to W Aviation should this item not move forward tonight. Further comment ensued.

City Attorney Boileau confirmed conversations with Mr. James regarding language in the lease that allows FXE to address safety or nuisance concerns related to pedestrian ingress and egress from the property.

Mayor Trantalis noted that this issue does not involve the City. Further comment and discussion ensued. Commissioner Moraitis explained her perspective.

Commissioner Moraitis introduced this Resolution which was read by title only.
