**TITLE:** Resolution Approving a Locally Funded Agreement and an Escrow Agreement with the Florida Department of Transportation for the Powder Color Coating of Street Traffic Mast Arm Assemblies on SR A1A and Terramar Street - \$25,000 - **(Commission District 2)**

**Recommendation**

It is recommended that the City Commission adopt a resolution authorizing the City Manager to execute a Locally Funded Agreement and an Escrow Agreement in substantially the form attached in Exhibits 1 and 2 with the Florida Department of Transportation in the amount of \$25,000 for the installation of two black powder coated trombone mast arm assemblies at the intersection of SR A1A and Terramar Street.

**Background**

The Florida Department of Transportation (FDOT) performed an assessment of the trombone mast arms at the intersection of SR A1A and Terramar Street and determined that the existing structures need to be replaced. In June 2019, the mast arms were removed and replaced with temporary concrete poles and span wires. FDOT will be replacing the trombone mast arms with its standard product, which will not aesthetically match the existing mast arms at this intersection and along SR A1A between Harbor Beach Parkway and NE 9<sup>th</sup> Street. The City can enter into a locally funded agreement with FDOT to powder coat the new mast arms to match the existing signals on A1A.

FDOT has programmed the installation of the permanent black powder coated trombone mast arms for Summer 2020, at which time the temporary concrete and span wire poles will be removed.

**Resource Impact**

The resource impact to the City is in the amount estimated at \$25,000.00 based on the quote provided by FDOT's contractor.
