

RESOLUTION NO. 20-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE MAINTENANCE OF THE POWDER COLOR COATED TRAFFIC SIGNAL MAST ARM ASSEMBLIES AT THE INTERSECTION OF SR A1A AND TERRAMAR STREET; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Transportation ("FDOT") performed an assessment of the trombone mast arms at the intersection of SR A1A and Terramar Street and determined that the mast arms need to be replaced; and

WHEREAS, FDOT's standard mast arm assemblies do not include powder color coating; and

WHEREAS, the existing mast arms along SR A1A in Fort Lauderdale between Harbor Beach Parkway and NE 9<sup>th</sup> Street are black powder coated; and

WHEREAS, FDOT's standard mast arms assemblies would not match the remaining trombone style mast arms along SR A1A; and

WHEREAS, FDOT will replace the mast arms with trombone style mast arms and will powder coat the new assemblies to match the existing signals on A1A; and

WHEREAS, the City will be required to maintain the powder coating on the mast arm assemblies at the intersection of SR A1A and Terramar Street through a Maintenance Memorandum of Agreement ("MMOA"); and

WHEREAS, the City of Fort Lauderdale ("City") and the Florida Department of Transportation ("FDOT") desire to execute an MMOA to maintain the specific elements constructed under Project Number 436219-3-72-01 to include the maintenance of the black powder coated mast arms at SR A1A and Terramar Street;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the Maintenance Memorandum of Agreement with the Florida Department of Transportation for the maintenance of the powder coating of the mast arms at the intersection

of SR A1A and Terramar is hereby approved, and the City Manager is hereby authorized to execute the agreement.

SECTION 2. The office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.

SECTION 3. That this Resolution shall be in full force and effect upon final passage.
