(Commission Districts 1, 2, 3 and 4)

## **Recommendation**

It is recommended that the City Commission approve an increase in funds to Contract No. 565-11668 for citywide janitorial services with United States Service Industries, Inc. ("USSI") in the amount of \$69,692.

# **Background**

On March 1, 2016, the City Commission approved Contract 565-11668 for citywide janitorial services with United States Service Industries, Inc. in the amount of \$385,990 (CAM 16-0203). This is a two-year contract with two, two-year renewal options, contingent upon appropriation of funds. Over the course of the contract, Procurement Services administratively approved increases to the contract totaling \$38,599, increasing the contract value to \$424,589.

USSI has requested an increase of 5 percent for the final two-year renewal term effective April 1, 2020. The request is due to increased labor costs of 5.09% since the beginning of the contract. The additional funding request would cover USSI's increase, as well as additional services at various City locations. The combined increase in costs amounts to \$69,692 which is inclusive of the 5 percent increase, for a new estimated annual contract total of \$494,281. The amount of \$27,578 is for the remainder of this fiscal year's expenses.
