Mayor Trantalis opened the public hearing.

Mayor Trantalis recognized John Gagne, 520 SE 5th Avenue. Mr. Gagne cited infrastructure concerns, urging the Commission to declare a moratorium on building until infrastructure is corrected, expounding on related details.

Mayor Trantalis recognized Kevin Cochrane, 2100 S. Ocean Lane. Mr. Cochrane inquired about the process and timeline for Infrastructure Task Force Committee (ITF) recommendations and requested a moratorium on any net new development until the ITF comes back with a formal recommendation based on an assessment of infrastructure. Mr. Cochrane inquired if the ITF would be responsible for water quality and waterway remediation and related items.

Mayor Trantalis explained the Commission did not give a timeline but requested the ITF work as aggressively as possible. The ITF has not been requested to address water quality. City Manager Chris Lagerbloom explained current efforts regarding water quality. E. Sciences, Inc. is doing an environmental impact assessment and will make recommendations. Commissioner Sorensen concurred with the recommendation to have a board address water quality and remediation. City Manager Lagerbloom recommended the Sustainability Advisory Board, confirming he would pursue.

Mayor Trantalis recognized Jeff Maggio, 639 NE 17th Way. Mr. Maggio commented on his perspective, inquiring about equipment to rehabilitate and restore the waterways. City Manager Lagerbloom explained aspects that prevent protein skimming, stating a decision was made to move forward with aerators and noting additional analysis is ongoing. Following the assessment and recommendations, the City will swiftly move forward.



Mayor Trantalis recognized Paul Chettle, 200 South Birch Road. Mr. Chettle commented on his opposition to this item, expounding on previous ITF recommendations, citizen petitions and the prior administration's actions. He urged aggressive pursuit of infrastructure needs.

Mayor Trantalis responded, explaining that the ITF approached the Commission to extend its term to take on a more meaningful role. He expounded on the perspective of the current Commission and administration, confirming the Commission is taking the most responsible path to address infrastructure.

Mayor Trantalis recognized Charles King, 105 N. Victoria Park Road. Mr. King commented on his perspective regarding infrastructure and actions of the previous Commission and administration.

Mayor Trantalis recognized Jay Koenigsberg, 4460 N. Federal Highway. Mr. Koenigsberg commented on his perspective regarding a moratorium, expounding on related details and confirming his opposition.

Mayor Trantalis recognized Mitchell Vitale, 725 NE 17th Way. Mr. Vitale questioned aspects of infrastructure related items, including fines, terms of credit related for funding infrastructure projects and rehabilitation of waterways. Mayor Trantalis reviewed Commission efforts, expounding on details.
