- TITLE: Motion Approving Contract for Architectural Design and Post-Design Construction Administration Services for Fire Station No. 13 – ACAI Associates, Inc. - \$660,585 - (Commission District 2)

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the architectural design and post-design construction administration services for Fire Station No. 13 with ACAI Associates, Inc. ("ACAI"), in the amount of \$660,585.

Background

On August 19, 2014, the City Commission approved the final ranking and commencement of contract negotiations for architectural design and construction administration services for the new Fire Station No. 13, Contract No. 946-11424 with the top ranked proposer, ACAI (CAM 14-0929). Since the commencement of contract negotiations, the City has evaluated several locations for the new Fire Station No. 13 and Ocean Rescue facility. The final decision was to proceed with the development of the new fire station at 2871 East Sunrise Boulevard, Fort Lauderdale. The scope of services includes, but is not limited to, the design, permitting, bidding services, and post-design construction administration services for Fire Station No. 13.

Staff is requesting approval to award a contract with ACAI for the architectural design and construction administration services of Fire Station No.13.

Resource Impact

There will be a fiscal impact to the City in the amount of \$660,585 for the contract award with reimbursables included and \$97,661 for estimated in-house project management fees. The total estimated project costs will be \$758,246. Funds for this project in the amount of \$758,246 are available in the FY 2020 Community Investment Plan accounts listed below:
