AMENDMENT #001 TO FY 2019 – 2020 PARTICIPATION AGREEMENT WITH

Mount Olive Development Corporation (MODCO) For Repayment of HOPWA Funding

THIS FIRST AMENDMENT, ("Amendment") with an effective date of March 1,2020 by the City of Fort Lauderdale (also known as the "City") and Mount Olive Development Corporation (MODC). (also known as the "Participant").

WHEREAS, the City entered into an Agreement dated October 1, 2019, (the "Agreement"), with the Participant in accordance with the 2019-2020 Annual Action Plan approved on July 9, 2019 (CAM# 19-0568); and

WHEREAS, the City receives Housing Opportunities for Persons with AIDS (HOPWA) funding from the U.S. Department of Housing and Urban Development ("HUD") to undertake housing activities for persons living with HIV/AIDS.

WHEREAS, in accordance with the City's Consolidated Plan for 2015-2020 and approved the Annual Action Plan for 2019-2020, (collectively referred to herein as the "Plans") both parties wish to modify the Agreement to decrease the allocation of funding by \$129,860.17 in accordance with the Plans; and

WHEREAS the Plans provide for funding for Participant's program and authorize the proper City Officials to enter this Amendment.

NOW, THEREFORE, both parties mutually agree that the Agreement is hereby amended as follows:

TERM AND TIME OF PERFORMANCE


- 1. The decrease of funding that will be recaptured as follows over a period of 24 months beginning March 1, 2020:
- 2. A Minimum of 24 equal payments in the amount of \$5,410.84 will be debited against each monthly reimbursement request submitted by MODCO to the City.
- 3. Should the Participant discontinue to provide housing for HOPWA eligible persons during this time period, the full amount outstanding at such time will become due and payable.

4.-If the Participant fails to meet any of the agreed upon repayment terms set forth in this Amendment, City shall not be obligated to provide additional funding as contemplated under future Agreements.

Except as revised by this Amendment, the Agreement remains unmodified and in full force and effect in accordance with the terms thereof. This Amendment is expressly contingent upon the approval of the City and shall become effective only when signed by all parties.
