TITLE:	Motion Approving Contract for the Fiveash Water Treatment Plant Media Filters Rehabilitation Project – Cardinal Contractors, Inc \$1,869,000 - (Commission Districts 1, 2, 3, 4)

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the Fiveash Water Treatment Plant Media Filters Rehabilitation Project with Cardinal Contractors, Inc., in the amount of \$1,869,000.

Background

This project is for the rehabilitation of twenty-two media filters at the Fiveash Water Treatment Plant. The filters remove contaminants and other impurities from our raw water (media), thereby providing clean and healthy water to our neighbors. The scope of work includes, but is not limited to, the complete rehabilitation of filter numbers 5 and 13, and the partial rehabilitation of filter numbers 1 - 4, 6 - 12, 14 - 16, and 20 - 22. This project includes procurement, removal, disposal, construction, testing, and placing into service the rehabilitated filters.

On January 14, 2020, the Procurement Services Division issued Invitation to Bid No. 12368-903. The City received three bids in response to the solicitation, which were opened on February 26, 2020. One of the three vendors that responded indicated they are either a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise. All bids were reviewed for compliance with the solicitation specifications. The bid submitted by Cardinal Contractors, Inc. has met all the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bid.

Resource Impact

There will be a fiscal impact to the City in the amount of \$1,869,000 for the contract award with the allowances included and \$228,476 for construction engineering inspection services fees and estimated in-house project management fees for a total of \$2,097,476. Funds for this purchase in the total amount of \$1,977,476 are available in the FY2020 Community Investment Plan in the accounts listed below with \$120,000 contingent upon the approval and appropriation of the consolidated budget amendment CAM #20-0090 on May 5, 2020.
