Public Transportation Grant Agreement with Florida Department of Transportation for the Northwest Community Link and Neighborhood Link

Routes - \$200,000 - (Commission Districts 2, 3 and 4)

Recommendation

It is recommended that the City Commission adopt a resolution authorizing the City Manager to accept grant funds on behalf of the city and to execute a Public Transportation Grant Agreement with the Florida Department of Transportation (FDOT) in the amount of \$200,000.00 for operating costs for the Northwest Community Link and Neighborhood Link routes.

Background

The Transportation and Mobility Department has an ongoing relationship receiving support from FDOT for Sun Trolley routes to support operations of the revised Northwest Community Link and Neighborhood Link routes. The grant allows for up to \$200,000.00. This grant will be for the operation of the Northwest and Neighborhood Community Bus route. The new grant agreement will become effective on execution by both parties and will run through April 30, 2022.

Resource Impact

There is a positive fiscal impact to the City in the amount of \$200,000.00 which will supplement existing City funding resources. The City will be using existing local funding sources to cover expenses in excess of the amount of FDOT's participation and any cost overruns or deficits involved. Funds are being appropriated contingent upon the approval of the Consolidated Budget Amendment CAM 20-0090.
