WHEREAS, the City of Fort Lauderdale, Florida ("the City") is interested in completing the following described Project for the enjoyment of the citizens of Fort Lauderdale, Broward County and the State of Florida:

Project: North Fork Riverfront Park - Phase I

<u>Brief Description of Project</u>: Grant funding will be utilized for final site plan design and permitting of the North Fork Riverfront Park; and

WHEREAS, Florida Inland Navigation District ("FIND") financial assistance is required for the Project referenced above; and

WHEREAS, staff is seeking additional grant funding in the amount of \$75,000.00 for eligible projects under the FIND Waterways Assistance Program; and

WHEREAS, this grant requires a City match of \$75,000.00 under the FIND Waterways Assistance Program; and

WHEREAS, Section 4.01(b) of the City Charter of the City of Fort Lauderdale requires that Mayor, City Manager, City Attorney and City Clerk execute all contracts, agreements or other instruments to which the City is a party under which the City assumes any liability; and

WHEREAS, the City Charter further provides that the City Commission has the authority to delegate by resolution to another person the authority to execute these instruments;
