TITLE: Motion Approving Contracts for Hortt Park and Coontie Hatchee Parks
Playground Replacement Projects -\$600,841 - Rep Services, Inc. -
(Commission District 4)

Recommendation

It is recommended that the City Commission approve contracts, in substantially the forms attached, for the Hortt and Coontie Hatchee Parks Playground Replacement Projects with Rep Services, Inc., via Clay County Contract No. 18/19-2 in the total amount of \$600,841 for both parks.

Background

These projects are for the replacement of playground equipment at Hortt Park at the cost of \$316,394 and Coontie Hatchee Park at the cost of \$284,447, for a total of \$600,841. The scope of work includes, but is not limited to, the construction of two new playgrounds with multiple play equipment pieces for both 2-5 and 5-12 year old children. The work includes surfacing replacement at both parks and replacement of the exercise equipment at Coontie Hatchee Park. Also included in this purchase are freight charges and labor to construct the playground.

This item is contingent on City Commission acceptance of the recommendation of the Parks, Recreation and Beaches Advisory Board in a public hearing via CAM #20-0201 and CAM #20-0207.

Pursuant to Section 2-181(f)(5)(b), Code of Ordinances of the City of Fort Lauderdale, Florida, the City may piggyback a contract entered into by another governmental or public entity and a provider of supplies or services required by the City, if the chief procurement officer (CPO) determines that it is practicable and advantageous for the city to employ this method of procurement. The CPO has determined that it would be practicable and advantageous for the City to use this method of procurement for the agreement. This purchase will be made in accordance with Clay County Contract No. 18/19-2 from Rep Services, Inc. in the total amount of \$600,841.

Resource Impact

There will be a fiscal impact to the City in the amount of \$600,841 for the contract award, \$10,000 for permit fee allowances, and \$120,900 for estimated in-house project management fees. The total estimated project costs will be \$731,741. Funds for these contracts in the amount of \$731,741 are available in the FY 2020 Community Investment Plan accounts listed below:
