AMENDING THE CITY OF FORT LAUDERDALE FINAL FY 2020 - FY 2024 COMMUNITY INVESTMENT PLAN FOR THE FISCAL YEARS BEGINNING OCTOBER 1, 2019, AND ENDING SEPTEMBER 30, 2024, AS AMENDED, BY TRANSFERRING FUNDS AS SET FORTH IN CITY COMMISSION AGENDA MEMO #20-0091, ABANDONING THE SOUTH ANDREWS PARKING SPACE/SPACE METER INSTALLATION AND THE CPG/RIVERWALK CENTER PA AND CALL BOX SYSTEM PROJECTS, AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 19-184, adopted on September 17, 2019, the City Commission of the City of Fort Lauderdale, Florida, adopted the City of Fort Lauderdale Revised FY 2020 Final All Funds Budget for the Fiscal Year beginning October 1, 2019, and ending September 30, 2020; and

WHEREAS, pursuant to Resolution No. 19-182, adopted on September 17, 2019, the City Commission of the City of Fort Lauderdale, Florida, adopted the City of Fort Lauderdale Final FY 2020 - FY 2024 Community Investment Plan for the Fiscal Years beginning October 1, 2019, and ending September 30, 2024;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City of Fort Lauderdale Revised FY 2020 Final All Funds Budget for the Fiscal Year beginning October 1, 2019, and ending September 30, 2020, as amended, is hereby amended by appropriating and transferring funds as set forth in City Commission Agenda Memo #20-0091, a copy of which is attached hereto and incorporated herein.

SECTION 2. That the City of Fort Lauderdale Final FY 2020 - FY 2024 Community Investment

Plan for the Fiscal Years beginning October 1, 2019, and ending September 30, 2024, as amended, to the extent appropriated for the Fiscal Year beginning October 1, 2019, and ending September 30, 2020, is hereby amended by transferring funds as set forth in City Commission Agenda Memo #20-0091.

<u>SECTION 3</u>. That the South Andrews Parking Space/Space Meter Installation and the CPG/Riverwalk Center PA and Call Box System Projects contained in the Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Years beginning October 1, 2019, and ending September 30, 2024, as amended, are hereby abandoned.

<u>SECTION 4</u>. That if any clause, section, or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

#### **Recommendation**

. .

It is recommended that the City Commission adopt a resolution amending the Fiscal Year (FY) 2020 Budget and FY 2020 – FY 2024 Community Investment Plan (CIP), and abandoning the South Andrews Parking Space/Space Meter Installation and the CPG/Riverwalk Center PA and Call Box System Projects.

#### **Background**

Examples of recommended actions within the budget amendment are:

- transfer between funds;
- transfer between capital and operating budgets;
- transfer between capital projects;
- acceptance and appropriation of grant funding;
- amendment to staffing level;
- appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff recommends that the City Commission amend the FY 2020 Final Budget and FY 2020 – FY 2024 Community Investment Plan by approving the following transfers and appropriations:

# Transportation and Mobility

# A. Transfer between Capital Projects – Parking Fund – North Galt Shops Project - \$517,985

# Abandoning the South Andrews Parking Space/Space Meter Installation and the CPG/Riverwalk Center PA and Call Box System Projects.

The Transportation and Mobility Department requests that the South Andrews Parking Space/Meter Installation and CPG/Riverwalk Center PA and Call Box System capital projects be abandoned, and the project balances transferred to the North Galt Shops Project. The North Galt Shops Project is currently underway and requires additional funding. Transferring the total remaining balance in the projects identified above in the amount of \$517,985 will provide the necessary funding to complete the project. There is an associated CAM 20-0420.

Staff recommends that the City Commission amend the FY 2020 – FY 2024 Community Investment Plan (CIP) in the amount of \$517,985 to complete the North Galt Shops Project.

# Parks and Recreation

## B. Transfer of Un-used Grant Match Funds – Grant Fund, General Fund – Broward County Tourism Program/ Great America Beach Party 2018 Grant Match -\$25,000

In June 2018, the City of Fort Lauderdale was awarded \$25,000 to promote arts and tourism in Broward County through the City's Memorial Day Weekend Great American Beach Party activities. The City provided the required cash match of \$25,000 from the General Fund. The 2018 Great American Beach Party event was cancelled due to a threatening tropical storm; however, the City still incurred expenses associated with the event preparation. The expenses and reimbursement associated with the grant posted directly to the Parks and

Recreation Department's operating budget. As a result, the full \$25,000 is still available in the grants match account.

Staff recommends that the City Commission amend the FY 2020 Operating Budget in the amount of \$25,000 to de-appropriate the un-used Broward County Tourism Program Great America Beach Party 2018 grant match.

## C. Appropriation of Grant Funds and transfer of Grant Match – Grant Fund, General Fund – Clean Vessel Act Grant - \$86,267

The City was awarded a \$64,700 Clean Vessel Act Grant from the Florida Department of Environmental Protection (DEP).

The funds will be used to renovate and repair one of the vessel sewage pump out stations at the City's New River Docking Facility which provides free pump out service to dock customers and area commercial and recreation vessels. The City received bids for the work and the total project costs are \$86,267 for system repairs. This grant will fund up to 75% of these costs and the City is required to cover the remaining 25%. Matching funds in the amount of \$21,567 have been identified within the Parks and Recreation Marine Facilities FY 2020 operating budget to be transferred for this purpose.

Staff recommends that the City Commission amend the FY 2020 Operating Budget in the amount of \$86,267 for the Clean Vessel Act Grant. This item is contingent upon the approval 06/02/2020 Page 3 of 10 CAM #20-0091

## D. Transfer Between Capital Projects – Central Beach Redevelopment CRA CIP Fund – Aquatics Complex Renovations - \$19,254

On October 5, 2016 the City Commission approved Task Order No. 4 from Synalovski Romanik Saye, LLC (SRS) to provide a design criteria package and professional services for the proposed Fort Lauderdale Aquatic Center/ Parking Garage Project. They have completed all work in the criteria package, as of May 1, 2020 leaving an unspent balance of \$19,254 in the project.

The Community Redevelopment Agency (CRA) is requesting to transfer the remaining unspent balance into the Aquatic Complex Renovations Project to assist with ongoing expenditures.

## E. Transfer Between Funds – Ft Lauderdale Community Redevelopment Agency Fund, CRA Business Incentives Fund – Emergency Business Assistance – \$63,290

Novel Coronavirus Disease 2019 (COVID-19) has limited the capacity of small businesses to serve customers. With these effects, COVID-19 has reduced the inflow of revenue of small businesses which ultimately resulted in job loss.

The Community Redevelopment Agency (CRA) is requesting to reduce the operating budget for the Central City Operations in the amount of \$63,290; \$30,000 from Ad/Marketing and \$33,290 from Other Services. The identified funds are no longer needed based upon assessed costs for the rezoning project. Transferred funds are made available to assist with loans to small businesses within the Central City impacted by COVID-19.

Staff recommends that the City Commission amend the FY 2020 Operating Budget in the amount of \$63,290 to assist small businesses impacted by COVID-19. There is an associated CAM #20-0405.

## F. Appropriation of Grant Funds – Grant Fund – Coronavirus Emergency Supplemental Funding Program- \$265,921

The Coronavirus Emergency Supplemental Funding (CESF) Program provides funding to assist eligible states, local units of government, and tribes in preventing, preparing for, and responding to the coronavirus. Funds awarded under the CESF Program must be utilized to prevent, prepare for, and respond to the coronavirus. Allowable projects and purchases include, but are not limited to, overtime, equipment (including law enforcement and medical personal protective equipment), hiring, supplies (such as gloves, masks, sanitizer), training, and travel expenses.

The City of Fort Lauderdale Police Department is eligible to receive \$265,921 in FY 2020 CESF funding, which will be utilized to acquire personal protective equipment and critical supplies and equipment for all personnel having direct contact with the public in the hopes of reducing their exposure to the virus and/or spreading it to others. The grant period is January 20, 2020 through December 31, 2021.

Staff recommends that the City Commission amend the FY 2020 Operating Budget in the amount of \$265,921 for the Coronavirus Emergency Supplemental Funding Program. This item is contingent upon the approval of the grant acceptance CAM #20-0409.

#### Public Works

#### G. Transfer between Capital Projects - Fleet Services Vehicle Rental Operations Fund - Automatic Light-Duty Car Wash and Oil/Water Separator Replacement -\$159,750

This project will remove and replace the current light duty drive-through car wash located at Fleet Services 220 SW 14<sup>th</sup> Avenue, with an efficient, automated design. The current unit often requires costly repairs and maintenance due to the drive-to-brush/drive-through requirement design, creating a blind spot where cars are continually driving over the guard rails damaging the carwash. The proposed washing system will sense the type of vehicle when it drives in and wash according to the design and type of vehicle. The new design is intended to avoid damage to the car wash mechanism and vehicles.

Additionally, the oil/water separator associated with the car wash must be replaced to meet environmental code requirements.

Funding is available in the Environmental and Sustainability Management System (ESMS) capital project. The ESMS project scope was reduced due to the proposed placement of the new Police Headquarters.

Staff recommends that the City Commission amend the FY 2020 – FY 2024 Community Investment Plan in the amount of \$159,750 for replacement of the automatic light-duty car wash and oil/water separator.

#### H. Appropriation of Grant Funds – Grant Fund – CARES Act Airport Grant for Fort Lauderdale Executive Airport - \$157,000

The City of Fort Lauderdale was awarded grant funds in the amount of \$157,000 from the Federal Aviation Administration in accordance with the CARES Act to provide funding to help offset a decline in revenues arising from diminished airport operations and activities at the Fort Lauderdale Executive Airport as a result of the COVID-19 Public Health Emergency. The purpose of this Grant is to maintain safe and efficient airport operations. Such purposes will include the reimbursement of an airport's operational and maintenance expenses incurred no earlier than January 20, 2020. The Airport intends to use this grant to fund a combination of safety and security enhancements such as fence and gate improvements, and replacement of security cameras around the Airport.

Staff recommends that the City Commission amend the FY 2020 Budget in the amount of \$157,000 for the CARES Act Airport Grant. The associated grant acceptance CAM #20-0356 was approved by the City Commission on May 19, 2020.

# I. Appropriation of Fund Balance - Airport Fund - Runway Incursion Mitigation - \$1,219,472

The Federal Aviation Administration (FAA) has developed a comprehensive and multiyear program to identify, prioritize, and implement solutions to address locations to mitigate runway incursions caused by an aircraft. The Fort Lauderdale Executive Airport staff have identified nine (9) areas of concern that could potentially lead to unauthorized runway incursions. The FAA has indicated funds are available for the Runway Incursion Mitigation Project, but an application must be submitted as soon as possible. However, a bid must be completed prior to receiving the grant. Therefore, the Airport needs to temporarily fund the project in order to complete the bid process. Funds are available in the Airport's fund balance.

Staff recommends that the City Commission amend the FY 2020 Operating Budget and FY 2020 Community Investment Plan in the amount of \$1,219,472 for the Runway Incursion Mitigation Project.
