TITLE: Ordinance Amending Section 13-55- Fireworks Manufacture; Public Display Permit by Amending Requirements for Fireworks and Pyrotechnic Displays and Assessed Fees – (Commission Districts 1, 2, 3 and 4)

Recommendation

It is recommended that the City Commission approve the ordinance amending the language in Section 13-55- Fireworks Manufacture; Public Display Permit for the requirements for fireworks and pyrotechnic displays and assessed fees.

Background

The city's ordinance for fireworks permits has not been updated for several years and the language is not current. There are also changes in the permit process over the past years which have not been added to ordinance.

The changes are as follows:

- The new language updates the terminology used in today's permit process and adds the requirements that are currently in place for the permit review to be approved;
- The new language adds new definitions for pyrotechnics permits;
- The fee was increased from \$25.00 to \$375.00 to cover the cost associated with the permit review and approval and the first two hours of the fire watch that is required by the Fire Code. The fire watch is usually a separate fee that causes confusion at the time of permit and usually takes a few months to collect;
- An additional non-refundable fee was added for late applications to cover the extra cost of staff time needed to perform the review after hours; and
- A change was made to have the Fire Marshal approve all permits to match the current code requirements for pyrotechnics.

There will be a slight increase to the general fund revenues from Fireworks Permit fees to cover the cost associated with the application approvals. The difference will be \$100 per permit. \$250.00 of the permit fee is already charged to the applicant for the first two (2) hours of a fire watch. The department reviews between 10-15 permits a year for

Resource Impact

There will be a positive fiscal impact to the City in the estimated amount of \$300.
