A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY ABANDONING SIXTY-THREE THOUSAND TWO HUNDRED NINETY AND NO/100 DOLLARS (\$63,290.00) APPROPRIATED TO THE CENTRAL CITY COMMUNITY REDEVELOPMENT AGENCY OPERATIONS FUND AND APPROPRIATING SAID AMOUNT TO THE EMERGENCY BUSINESS ASSISTANCE PROGRAM FUND; AND PROVIDING FOR AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY:

SECTION 1. That the abandonment of Sixty-Three Thousand Two Hundred Ninety and No/100 Dollars (\$63,290.00) appropriated to the Central City Community Redevelopment Agency Operations Fund and Appropriating said amount to the Emergency Business Assistance Program Fund, as set forth in the Community Redevelopment Agency Agenda Memo #20-0405 attached hereto, is hereby approved.

**Recommendation**

It is recommended that the Community Redevelopment Agency (CRA) Board of Commissioners approve a Budget Amendment of \$63,290 to the Emergency Business Assistance Program Fund.

**Background**

On March 1, 2020, in accordance with Governor Ron DeSantis' Executive Order Number 20-51, the State Surgeon General and State Health Officer declared a Public Health Emergency in the State of Florida from Coronavirus Disease 2019 (COVID-19), a severe acute respiratory illness that can be spread through human to human contact. This public health threat limited business operations in the City of Fort Lauderdale and throughout the Country. COVID-19 is a continuing threat and may have long term economic and financial loss.

COVID-19 has limited the capacity of small businesses to serve customers. With these effects, COVID-19 has reduced the inflow of revenue of small businesses which ultimately resulted in job loss.

Staff is requesting to abandon funds from Central City Operations totaling \$63,290; \$30,000 from Ad/Marketing and \$33,290 from Other Services. The proposed abandoned funds are no longer needed based on assessed costs for the rezoning project. Transferred funds will be made available to the Emergency Assistance Fund to assist with Small Business Loans within the Central City Area due to COVID-19.
