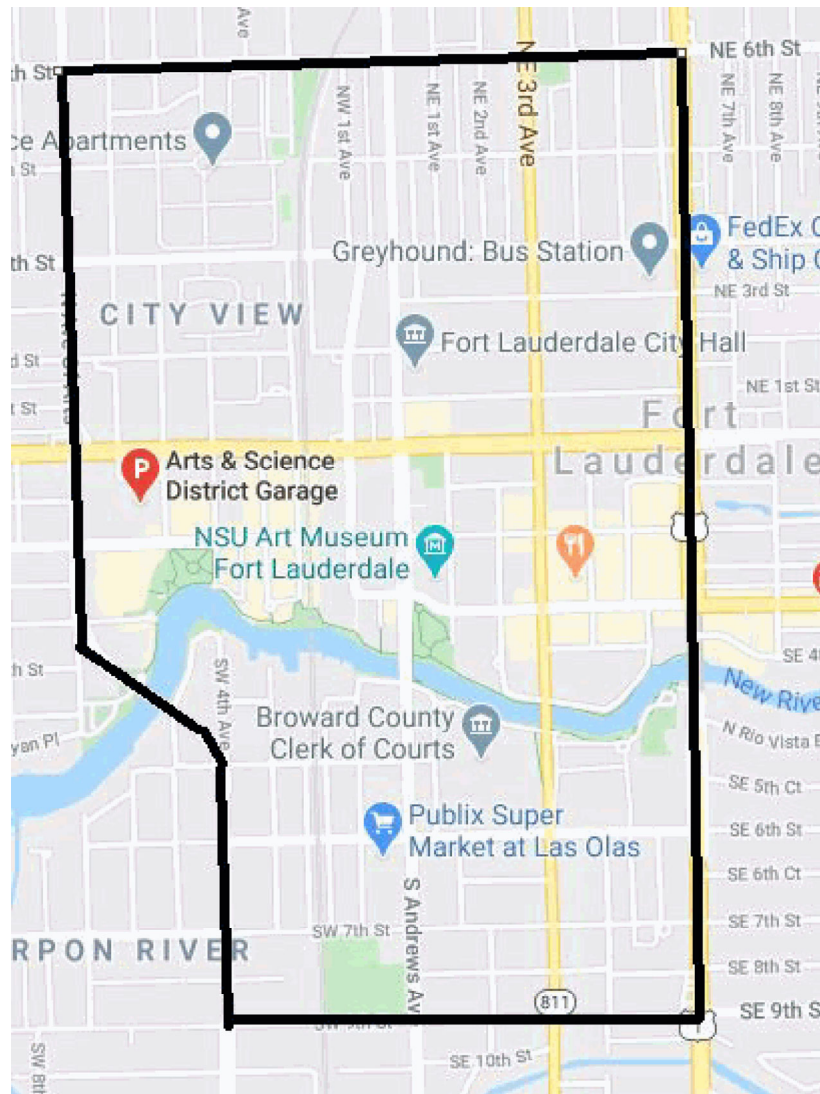

Legacy Events: Events with over two (2) years history in good standing

Major Events: Events with a sustained attendance of over 5,000 persons. These events require City Commission Approval.
