TITLE: Motion Approving Contract for George T. Lohmeyer Regional Wastewater

Treatment Plant Freight Elevator Replacement – Maverick United Elevator,

LLC - \$839,000 (Commission Districts 1, 2, 3 and 4)

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the George T. Lohmeyer Regional Wastewater Treatment Plant ("GTLWWTP") Freight Elevator Replacement with Maverick United Elevator, LLC, in the amount of \$839,000.

Background

The GTLWWTP has an aging freight elevator located in the Dewatering Building. The Dewatering Building is a 3-story building with seven (7) dewatering belt presses located on the 3rd floor. The freight elevator is necessary to maintaining these belt presses by transporting large belts and other parts.

The freight elevator has been subject to regular expensive maintenance repairs due to the extremely corrosive environment of the Dewatering Building. Staff procured a design consultant to prepare contract and bid documents for the replacement of the freight elevator.

On February 10, 2020, the Procurement Services Division issued Invitation to Bid No. 12371-103. The bid was extended three times due to COVID-19. The City received one bid in response to the solicitation, which was opened on May 8, 2020. The bidder did not indicate their status as a Minority Business Enterprise, a Women Business Enterprise, or a Small Business Enterprise. The bid was reviewed for compliance with the solicitation specifications. The bid submitted by Maverick United Elevator, LLC., has met all the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bidder.

Resource Impact

There will be a fiscal impact to the City in the amount of \$839,000 for the contract award with \$327,000 in allowances included. Funds for this contract in the total amount of \$839,000 are available in the FY 2020 Community Investment Plan in the account listed below with \$700,000 pre-encumbered on requisition RQ2001507.
