- TITLE: Motion Approving Lease Amendment for Office Space from September 1, 2020 until September 1, 2025 for approximately \$686,313.90 (60-month gross rent) (Commission Districts 1, 2, 3 and 4)

### **Recommendation**

It is recommended that the City Commission authorize the first lease amendment to extend a Lease Agreement, for police use, in the amount of approximately \$686,313.90

### **Background**

In 2015, the City entered into a lease agreement for approximately 13,940 square feet of rentable space for police use and there is a need to extend the term of the lease for another five (5) years. The lease amendment will expire on September 1, 2025. In addition, we have included language on the amendment to allow the City the right to terminate the Lease after year four (4) of the renewal term in the event a new Police Department Headquarters has been built.

A summary of the terms of the lease extension are as follows:

Lease Term

Lease Type	Triple Net
Lease Term	5 years, 0 months
Lease Commencement Date	September 1, 2020
Lease Expiration Date	September 1, 2025

# Resource Impact

The annual cost of rental space will total \$140,366.07. FY 2020 lease expenditures for the month of September 2020 in the amount of \$11,697 will be covered in the current fiscal year's budgeted line items below. The remaining months will be included in the FY 2021 budget.
