Recommendation

It is recommended that the City Commission adopt a resolution authorizing the City Manager to execute a Locally Funded Agreement and an Escrow Agreement in substantially the form attached in Exhibits 1 and 2 with the Florida Department of Transportation in the amount of \$40,698.40 for Decorative Pedestrian Lighting for portions of State Road A1A, SE 17th Street and Seabreeze Boulevard.

Background

The Florida Department of Transportation (FDOT) will be installing pedestrian lighting with its standard product, which will not aesthetically match the existing pedestrian lighting in this area. The City can enter into a locally funded agreement with FDOT for decorative finishes to match existing conditions on State Road A1A, SE 17th Street and Seabreeze Boulevard.

Resource Impact

The resource impact to the City is in the amount of \$40,698.40.
